All Bidders submitting bids shall encourage participation from qualified minority subcontractors to perform any portions of the work in the project scope(s) not being performed by the Bidder's own forces. Bidders shall submit written evidence with their proposal that participation from qualified minority sub-contractors has been solicited.
