- 1. Bids are due 11:00 a.m. on October 17, 2024 in Ginsberg Hall Room 103
- 2. Project shall be started after May 12, 2025 (week after classes are over)
  - a. Contractor shall verify storm sewer project has been completed prior to construction
- 3. Final completion on or before August 2, 2025
- 4. Anticipated award approximately 3-4 weeks after bid date
- 5. Liquidated damages-\$1500/day
- 6. The Owner will be responsible for testing.
- 7. Lump sum bid-(1) mandatory alternate.
  - a. Pavement removal on western portion of the parking lot.
- 8. Submit everything as noted in Instructions to Bidders & Bid Form.
- 9. MBE Goal is 5% (not mandatory)
- 10. Notes on Construction
- 11. The contractor is responsible for public utility locates. The Owner will call for private utility locates.
- 12. Traffic -Keep drive open
- 13. The last addendum will be issued October 11<sup>th</sup>. All questions must be submitted by the end of the day on October 10<sup>th</sup>
