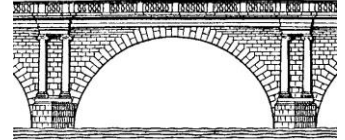

### **ADDENDUM #1**

Date: February 12, 2025

The attention of all prospective Bidders on the subject project is directed to the following change in project specifications:

Revise Technical Specification TS-9 as follows:

This technical specification shall be omitted. No undistributed quantities are called for on the Itemized Proposal.

Revise Technical Specification TS-10 to read as follows:

Incidental items considered to be subservient to major items which are required as necessary to construct the Project in accordance to the Plans shall be included in the Contractor's Bid.

Revise Technical Specification TS-11 to read as follows:

This technical specification shall be omitted in its entirety and read as follows: All quantities shall be measured and paid for based on the unit prices stipulated in the Itemized Proposal of the Contractor's Bid.

Revise Technical Specification TS-20 paragraph 2 to read as follows:

The cost of this work shall be included in Bid Item # 3 Maintenance of Traffic and no further payment will be made therefore.

Revise Technical Specification TS-22 paragraph 1 to read as follows:

The Contractor shall coordinate the relocation of any utility facility within the limits of the construction as required for either his convenience or the construction of the project. Any incidental utility relocation expenses incurred by the contractor shall be included in Bid Item #5 Utility Relocation, Coordination, Protection.

Revise Technical Specification TS-24 paragraph 8 to read as follows:

The cost of this item will be included in the Bid Item #4 Clearing of Project Limits and no further compensation will be paid.

Revise Technical Specification TS-25 to read as follows:

The Contractor shall remove and dispose of all rubbish within the limits of the contract and within the limits of the right-of-way lines. This cost shall be included in Bid Item #2 Mobilization and Demobilization.


