  - a. The grading plan is a balanced site.
  
11. Per page 19 are we to assume the following items are NOT included in this contract:
  - Erosion control devices other than temporary seed and straw.
    - a. Incorrect – a silt fence, inlet and outlet protection in the detention basin are required.
  
  - Stone, Asphalt & concrete paving other than the public road construction.
    - a. Confirmed.
  
  - Please confirm the boundaries for the sidewalk, curb and public road work are per the limits of prior ROW dedication as shown on C-100.

Co	CONSTRUCTION EXIT			A crushed stone pad located at the construction site exit to provide a place for removing mud from tires thereby protecting public streets.
Sd1	SEDIMENT BARRIER			A barrier to prevent sediment from leaving the construction site. It may be made of bales of straw or hay, brush, logs and poles, gravel, or a silt fence.
Sd2	INLET SEDIMENT TRAP			An impounding area created by excavating around a storm drain inlet. The excavated area will be filled and stabilized on completion of construction activities.
SI	STORMWATER OUTLET PROTECTION			A paved or short section of pipe (5'-15' min.) channel at the outlet of a storm drain system preventing erosion from the concentrated runoff.



**GRADING & EPSC PLAN**


